

Not long after I found out I had been raped, I learned that I was not the first girl abused by this guy. In fact, I was the third. When abortion was legalized in America, it allowed a rapist to be able to cover his tracks and abuse women again and again.

IS ABORTION THE MOST LOVING RESPONSE?

The pregnancy rate following rape is approximately 5%. It is estimated that 40% of these pregnancies are carried to term and half end in abortion, about 1% of all abortions.

Rape is not about sex, but is a violent misuse of the sexual act to fulfill the aggressor's deviant psychological, developmental and personal needs, including the need for power and control.²

WHEN THE INNOCENT CHILD CONCEIVED IN RAPE IS REJECTED, WHAT DOES THAT SAY ABOUT THE MOTHER OF THE CHILD?

The psychological recovery of the victim of rape requires that she accept that she has not brought the crime upon herself, that she understands the rapist's deviance, and that she forgives her attacker so she can respond without anger to others in loving ways. Killing her own child can only make it more difficult for her to fulfill these tasks of healing.

In fact, the child is a second victim of the rape. Totally innocent, the child exists because of another's crime. If she succumbs to the pressure to abort her child, violence again victimizes an innocent person.³

"I felt an emptiness that nothing could fill, and quickly discovered that the aftermath of abortion continued a long time after the memory of the rape had dimmed... Contrary to what everyone had told me, the abortion was much harder to deal with than the rape. The rape was a violent crime against me, an innocent victim. The abortion was the violent murder of my child, and I was a willing participant."

WHAT IS THE LOVING RESPONSE TO THE VICTIM OF RAPE?

Ryan Bomberger's biological mother was raped yet courageously chose to continue the pregnancy, giving him Life. He was adopted as a baby and grew up in a loving, multi-racial Christian family of 15.



"One woman made a selfless choice so that I can love and be loved.... I'm the 1% that is used all the time to justify 100% of abortions... Abortion activists call me the rapist's child... When do we ever define an innocent child by the crimes of either parent? This is only necessary to those whose ideology demands the dehumanization of that life to justify killing via abortion... My biological mother was strength personified. She chose to be stronger than her circumstances. I am beyond grateful for her courage and the incredible gift of life and love she gave to me, especially through adoption...Children conceived in rape are often considered by their biological mothers as the only redemption amidst the horrific devastation of rape... I am not the 'rapist's child'. I am her child. I am God's child. I'm one of thousands every year, given the opportunity to live, love and redeem what the rapist tried to destroy. Our stories are full of hope, full of love, full of burbose."4
