Unplanned Film Convicts, Re-Convicts, and Redeems

Unplanned is not a film to go see lightly. It certainly does not offer a fun cinematic experience, and it's far from the kind of flick you'd enjoy over popcorn or nachos. But it is an important film, which is made painfully clear in the first seven minutes as Planned Parenthood clinic director Abby Johnson (Ashley Bratcher) watches a gruesome first-trimester abortion take place before her very eves.

The film, which opened in theaters nationwide on March 29, follows Johnson's rise from clinic volunteer to clinic director, and her eventual pro-life conversion and spiritual redemption.

Based on Johnson's 2012 memoir, the film's true-to-life depiction of abortion earned it an R rating from the Motion Picture Association of America (MPAA) in Februrary. Since then, many have pointed out the hypocrisy in our culture which allows a teen to

have an abortion but prevents her from seeing a film about abortion.

But Johnson and the film's producers have taken the rating in strides, refusing to cut the graphic scenes and embracing the MPAA's categorization of the scenes as "violent."

"We are pushing the boundaries of what has never been before on such a wide scale by showing America exactly what abortion is—and abortion is disturbing. It's violent," Johnson said.

Along with the opening scene, the film's other graphic scene comes when Johnson endures the horror of a chemical abortion in her home bathroom. In an open letter to parents about the film's rating, Johnson said, "In real life, I hemorrhaged so badly I thought I was going to die," noting the movie captures her experience "without being gratuitous or gory."

The depiction of abortion in Unplanned is jarring and raw, and will certainly convict (and re-convict) moviegoers of the evil of abortion.

But it is jarring. And it is raw. And it could very well move countless post-abortive women and women considering abortion into the doors of their nearest pro-life ministry. Not only that, it will hopefully send current abortion workers to Johnson's own ministry, And Then There Were None, an organization which helps such

workers to leave the abortion industry and find healing.

That's why a screen at the end of the film prompts viewers to text HOPE to 73075 for resources on pregnancy help, abortion healing, and leaving the abortion industry.

In a recent Facebook post. Johnson shared with her followers that even before the film's release, she's already receiving contacts from workers seeking assistance:

"In the past four days, I have received three

emails from women who previously worked in abortion clinics and are looking for healing resources. In their emails, they all stated that they watched the TRAILER for Unplanned and realized that they needed healing from their past in order to really deepen their relationship with Christ.

"They realized that just from the trailer!! God is about to shake up this country in a powerful way on March 29th!!"

While the film's depiction of abortion has received the most ink in recent

weeks, it's this redemptive result which we'll hopefully be seeing more

PBS 'Frontline' Film on the Abortion Scene in Philadelphia Omits Kermit Gosnell

PBS's FRONTLINE episode "The Abortion Divide," an update of a piece by Mark Obenhaus that examined abortion politics in Pennsylvania in 1983, aired on April 23. The film bounced back and forth between the 1980s and today, ranging from the inner city of Philadelphia to the suburbs and recording five separate abortion procedures.

But one crucial topic was conspicuously missing: the crimes of Dr. Kermit Gosnell.

The most infamous abortionist in the country had a clinic in Philadelphia from 1979 to 2010, and a 2013 trial that found him guilty of multiple murders in the course of his practice. PBS never even mentions him.

There are many opportunities to bring Gosnell up, perhaps none more obvious than during this discussion about abortion regulations in Pennsylvania.

MARK OBENHAUS: In 1982, when the first film was shot, security was light. The waiting room was relaxed and felt like a doctor's office. The

staff wore street clothes. Then, the procedure rooms were sparce with a minimum of equipment. The clinic today has the look of a hospital. Anti-abortion groups in

Gosnell's Late-Term Abortion Practice

Dear friends,

New York has passed a pro-abortion law that allows abortion for essentially any reason up until birth. New York Governor Andrew Cuomo praised the "Reproductive Health Act" at its signing, and many other states have threatened to join in passing such laws. Prolife Americans are horrified by this legalized brutality. How can ordinary Americans support such horrors?

As a child, I lived in Germany with the U.S. military forces occupying the country after World War II. We were all painfully aware of the horrors of the Nazi concentration camps, which had been uncovered when the Allies marched into Germany at the end of the war. Ever since, the world has asked the obvious question: How could the "ordinary" people of Germany allow such atrocities to occur?

At the time, the answer from many Germans was: "I didn't know." Obviously, they had to have known of the "final solution" and the rounding up of the Jews. What they didn't know was the brutality that was inflicted upon the Jews behind the closed doors of the concentration camps. They had approved or tolerated the policy but were later horrified by the actual carnage that occurred in carrying out the policy.

Today, in America, we are living with the horrific practice of abortion. Most Americans don't want to know what legalized abortion is all about. The trial of Philadelphia abortionist Dr. Kermit Gosnell has brought the dark practice of abortion into the bright light of day. He was found guilty of manslaughter in the death of one of his clients and of first degree murder in the death of several viable babies, who were delivered alive and then killed by severing their spines with scissors.

The Gosnell case demonstrates what can occur after the unlimited and uncontrolled legalization of abortion opened the door to a money-making business. Unlike Gosnell, most abortion businesses presumably clean up the blood after they kill.

However, the most frightening thing about the Gosnell story is the way that our entire system of health care, law enforcement, and social justice failed to stop this brutal abuse of women and children. The Gosnell Grand Jury Report pointed out that "Pennsylvania is not a Third World country" but, nevertheless, there was a "complete regulatory collapse." For 17 years, no health agency visited his charnel house in spite of numerous indications that there were severe problems: women requiring hospitalization after an abortion at the Gosnell abortion chamber and complaints about horrific practices from both women patients and a former employee. Even when abortionists follow the law, it is the law that allows for the horrors of the killing.

What the Gosnell case reminds us is that abortion is the bloody, brutal killing of innocent children. In America, just under a million of our children are killed in this way every year. Even if the Pennsylvania government officials had done their jobs, the horror of death behind the closed doors of the country's abortion clinics would still occur. Americans, who hear about the Gosnell case are saying: "I didn't know." Like the Germans before them, they approve the policy but are horrified by the actual carnage that occurs in carrying out the policy.

It is the job of the pro-life movement to make sure that Americans truly know what abortion is. We must educate West Virginians about the Gosnell case. The movie, Gosnell, is now available on DVD. It was recently screened at the White House. Every American should see it. Just as the German people were forced to walk through the concentration camps in Germany after World War II, we must be forced to see the carnage that occurs every day in America in the name of "reproductive rights."

Born-Alive Abortion Survivors Protection Act

Virginia Governor Ralph Northam recently described, on a local radio program, how a baby would be treated if born alive from an abortion. He said the baby would be kept "comfortable" and a discussion would ensue as to whether or not the baby would be left to die. This occurred in a discussion over a bill that would allow abortions right up until the time of birth. These discussions have shocked West Virginians. Bills that legalize the killing of unborn babies until birth have clearly caused a blurring of the distinction between abortion and infanticide. West Virginians are asking, "Can this happen in West Virginia?"

A bill has been introduced in Congress that would protect infants born alive following an attempted abortion. It would require hospitals and medical personnel to exercise the same degree of care for the baby born alive as a result of a failed abortion, as would be given to any other preborn child at the same gestational age. It provides for immediate transport to facilities capable of caring for such children, and it provides for reporting requirements in the event the law isn't observed.

Although the bill has been introduced in Congress, the Democrats have repeatedly blocked it. Consequently, West Virginians for Life intends to introduce this bill into the 2020 Legislative Session to ensure that no baby in West Virginia is treated in such a callous way.

Defense of the Disabled and Medically Vulnerable

Options in Living Wills and Combined Power of Attorney Living Wills

West Virginia law at present includes suggested language for Living Wills that is generally used by most medical facilities in the state. These current Living Wills do not make clear that, when signers of these documents ask that medical treatment be removed, it includes the removal of food and water provided intravenously or by feeding tube. If patients do not wish to die from starvation and dehydration, they should not sign Living Wills. Our legislation corrects this dangerous possibility of confusion by providing clear choices on the Living Will form for patients to indicate whether artificially-provided food and fluids are desired.

- This legislation will improve the language in the Living Will.
- It will prevent the inadvertent starvation and dehydration of patients.
- It will promote patient autonomy and ensure informed consent.

The Non-Discrimination in Involuntary Denial of Treatment Act

West Virginians for Life will work to put a nondiscrimination clause in our state law to protect those with disabilities and the medically vulnerable.


Pro-Life Rally Day Cold but Remarks Warmed the Crowd

PBS Film Omits Gosnell

Pennsylvania and 23 other states have pressed for the passage of laws that mandate abortion clinics operate as "ambulatory surgical facilities."

CAROL TRACY, Executive Director, Women's Law Project: Pennsylvania implemented regulations under the Ambulatory Surgical Facilities Act, that governs everything from the width of hallways, to where sinks are located, to the HVAC systems, to the job descriptions. Abortion care providers have come into compliance with numerous regulations at great cost, at great financial cost to the women who need abortions. And also, it's limited the number of abortion providers in this state.

JENNIFER BOULANGER, Senior Director, Philadelphia Women's Center: We had to spend over \$500,000 on improvements that did nothing to improve the health of our patients.

The Gosnell Grand Jury Report explicitly said, "The abhorrent conditions and practices inside Gosnell's clinic are directly attributable to the Pennsylvania Health Department's refusal to treat abortion clinics as ambulatory surgical facilities."

Obenhaus wants viewers to believe Pennsylvania, in with 23 other states, were bullied by "anti-abortion groups" into adopting these laws. That's simply untrue. Pennsylvania's laws were enacted in response to Gosnell by a bipartisan majority in the Pennsylvania state house. But taxpayer-funded

PBS has always had a Gosnell blindspot: in 2012 Anchor Judy Woodruff admitted she was "not familiar with" Gosnell and PBS didn't cover his 2013 trial for over a month.

One of Tracy's complaints – regulations about the width of hallways – directly relates to the Gosnell case. The grand jury report, in describing the circumstances that led to the death of Karnamaya Mongar after an abortion, said when emergency personnel arrived at Gosnell's clinic, "responders had to waste precious more minutes trying to maneuver through the narrow cramped hallways that could not accommodate a stretcher."

In another emergency, "They discovered they could not maneuver stretchers through the building's narrow hallways to reach the patients (just as emergency personnel had been obstructed from reaching Mrs.

to be given this gift of life. And also, I, I can't do it right now. I can't accept that mantle in terms of the other lives that I'm taking care of and I'm responsible for.

Another mother, Shaharra, has four children and has already had one abortion. The episode shows the most of her abortion, including afterward, when we follow the cooler containing the body of her unborn baby (euphemistically called "pregnancy tissue") to a back room where a male technician pieces through the shredded remains to ensure the procedure was complete.

OBENHAUS: Shaharra chose to have a surgical abortion under IV sedation.

MALE NURSE: You might feel a little warm feeling going



Mongar)." And yet abortion clinics still chafe at being held to the same health standards as endoscopy, laser, and plastic surgery centers.

Over the course of the almost one-hour FRONTLINE episode, viewers watch three medication [chemical/RU486] abortions start and two surgical abortions. Two of the abortions involved sets of twins. That's seven tiny human heartbeats that were snuffed out on-camera.

One woman, named Taryn, already has two kids, is "recently single," and we find out with her during the vaginal ultrasound that she's aborting twins. After she takes the first pill, Taryn tells the camera:

What I hope I feel is a sense of peace, not only with myself and in the decision that I've made, but also a sense of peace with these two beings that I've chosen not to bring into the world. Thank you for choosing me, and I'm honored

through your IV site, okay? It's normal, and it will go away.

OBENHAUS: IV sedation was not an option for the patients at the clinic where the first film was shot.

[Excerpt from 1983 film] Female clinician: Easy does it. Nice and slow; lots of cramps.

OBENHAUS: Patients then were awake, and the procedure was uncomfortable, even painful.

MALE NURSE: You're drifting off to sleep, okay? Take some nice, big, deep breaths.

OBENHAUS: Most patients opt to have a surgical procedure. Like Shaharra, they want to leave the clinic with the abortion behind them.

ELIZABETH LIVERIGHT, M.D., Philadelphia Women's

Center: Surgical abortion is incredibly safe. The woman is in stirrups. We do a bimanual exam to feel the positioning of the uterus. I place the speculum, clean off the cervix, and then place a small clip on the top of the cervix to straighten out the uterine canal. The second part of the procedure is dilating the cervix, which is using instruments to gently open the entry into the uterus, and then removing the pregnancy tissue, using suction. It takes somewhere between two and five minutes. Complications are incredibly rare.

REBECCA MERCIER, **OB-GYN**, Philadelphia Women's Center: One of the most important components of safety with abortion procedures is making sure all of the pregnancy tissue has been removed from the uterus. The tissue is taken to a special room within the clinic. It is rinsed off. And it's looked at in a special dish with a little backlight on it that lets us confirm that we are seeing all the tissue that would be expected for the gestational age for the pregnancy. And that lets us know that there weren't any complications.

OBENHAUS: The gestational age of this fetus was nine weeks and one day.

MERCIER: Up to nine to ten weeks, it's just a small little piece of translucent sac tissue, with nothing that looks recognizable as any kind of fetal parts. After that, you do see small bits of tissue that are recognizable as fetal tissue.

Also of note, PWC abortionist Lisa Perriera, who the documentary notes is featured on Operation Resue's website (but they don't reveal it's because of her history of botched abortions leading to at least one patient death), calls infamous lateterm abortionist Dr. George Tiller, who was murdered in 2009, "one of the idols in our community."

But, again, no word on what they think of Gosnell.


