The theme of the West Virginians for Life State Convention on Saturday, October 19, **LIFE is nourished at the roots**, picks up the same theme as National Right to Life's convention earlier this summer. Held at Trinity Assembly of God in Fairmont, the doors will open at 9:00 a.m. for registration. The event begins at 10:00 a.m. and lasts until 3:00 p.m.

To equip you with the knowledge and skills to combat the pro-abortion rhetoric in our culture, WVFL has prepared a one-day fast-paced state pro-life convention geared to get West Virginians up to date with what is happening in the movement.

Guest speakers will be **Brenden and Nicole Flynn**, a unique couple whose traumatic brain injuries have not held them back from achievements when many doctors would have called for their demise pronouncing "low quality of life" over them. At one point the doctors wanted to give Brenden up for dead saying if he survived he would be nursing home bound the rest of his life. He has proven them wrong and now talks about his hospital experiences and rehabilitation openly. Nicole, too, suffered a traumatic brain injury. Together, they aim to give hope and want to spread their message of life and perseverance all over the world.

Other speakers include **National Right to Life Political Director Karen Cross** and **WVFL President Dr. Wanda Franz**. With her presentation titled *Tears to Triumph*, Cross will address the teens and tell them of her journey in the Pro-life movement. Additionally, convention goers can look forward to hearing Cross present information on the 2020 elections and what part attendees can play in bringing about positive pro-life change.

Mathis will inform attendees regarding the lone abortion clinic in the state. Learn the latest on the bubble zone ordinance and how that has affected the protest effort.

Teens will have their own special Day Camp geared specifically to teens while the adult convention is being held. In a separate space for most of the day, they will be led by our **National Right to Life Academy alum and Board Member, Lacey Evans**. Delegates **Kayla Kessinger** and **Caleb Hanna** (age 19) have promised to address the teens in addition to a representative from **Students for Life of America**.

A buffet luncheon as well as continental breakfast are included in the adult \$35 registration fee. Fairmont's Gourmet Catering always does a superb job with lunch. The WVFL Marion County Chapter will provide the continental breakfast.

Groups of 10 or more, pay only \$25 per person versus \$35. College students and teens pay \$20.

Childcare will be available, if enough notice is given. Cost for pre-teens (5-11 years) is \$7 per child. Birth to 4 years of age will be \$5 each.

What She Saw in that Teaching Hospital in WV



Nurse Maryann Lawhon is the Executive Producer of *The Voice of John*. The haunting story she shares, deserves to be heard

What would you do if you walked into a utility room in a hospital and found a baby laying naked on a counter? It happened to rookie nurse Maryann Lawhon in 1977. Not only that, but it happened at a teaching hospital in **Morgantown, West Virginia**. "It's an abortion. Leave it alone," she was told when she ran to get help.

Don't think that this is not happening. We know that it is and abortion survivors are coming forward. Pro-life advocate and abortion survivor Melissa Ohden heads The Abortion Survivors Network at theabortionsurvivors.com and she has been in contact with 260 survivors from 2012-2018. According to the site, "there could be as many as 44,000 survivors of late-term abortion in the United States alone." Ohden is among the fortunate ones, who survives to tell her story.

Nurse Maryann Lawhon made good on her promise to the aborted baby

From the President



Polling and the 2020 Election

Dear friends,

Gallup recently released polling data that shows that there has been an increase in pro-life sentiment across the country. When people are asked if they consider themselves to be pro-life or “pro-choice,” 60% of Americans identify with the pro-life position. This is because there has been a renewed awareness of what it means to be “pro-choice.” Our opponents have always hidden their support for late-term abortions, but that has all changed and Americans are appalled by it.

Today, every single one of the Democrat candidates for President of the United States has publicly claimed they support abortion until birth, including taxpayer funding of abortion. However, opposition to late-term abortions is overwhelming with 71% saying abortion should be illegal during the third trimester. Opposition to third trimester abortions includes 60% of Democrats, 85% of Republicans and 72% of Independents.

A Marist Poll taken in February showed one of the biggest pro-life shifts in history. Americans moved toward the pro-life direction on abortion by a 17% margin in one month after New York state legalized abortions up to birth. Once Americans know that the “pro-choice” position means the ability to “choose” abortion until birth, they realize that they can no longer identify with it.

While all the Democrat candidates for President of the United States have pro-abortion positions, President Trump has been the most pro-life President in history.

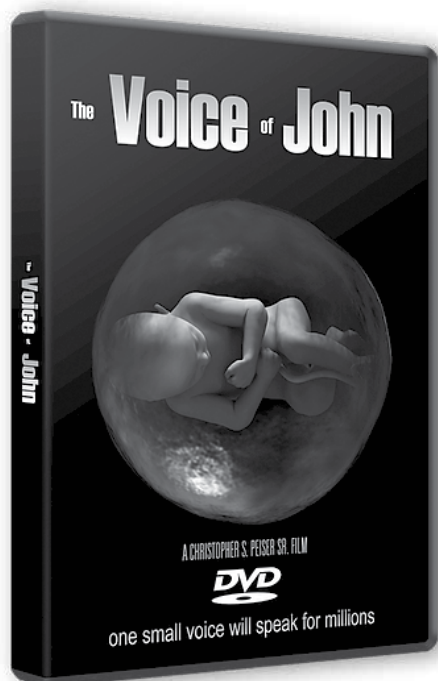
President Trump has been a powerful voice for the pro-life position. He said he would pick the kind of Supreme Court Justices who would “interpret the Constitution the way the founders wanted it interpreted,” and he has not disappointed his voters. In addition, he has used his Presidential powers to restore the international “Mexico City Policy,” which prevents tax funds from supporting the global abortion industry, including Planned Parenthood.

He supports pro-life legislation and would sign the Federal Pain-Capable Unborn Child Protection Act to protect children from suffering abortions after 20 weeks when the unborn child feels pain. He has pledged “to veto any legislation that weakens current pro-life federal policies and laws, or that encourages the destruction of innocent human life at any stage.” While waiting for Congress to act to pass laws, he has used his executive powers to ensure that Title X funding does not go to facilities that perform or refer for abortions.

West Virginians for Life is proud to support candidates who work to promote pro-life policies at both the state and federal levels. We are blessed to have pro-life leadership in the state and as representatives in Congress. We look forward to working for life in 2020.

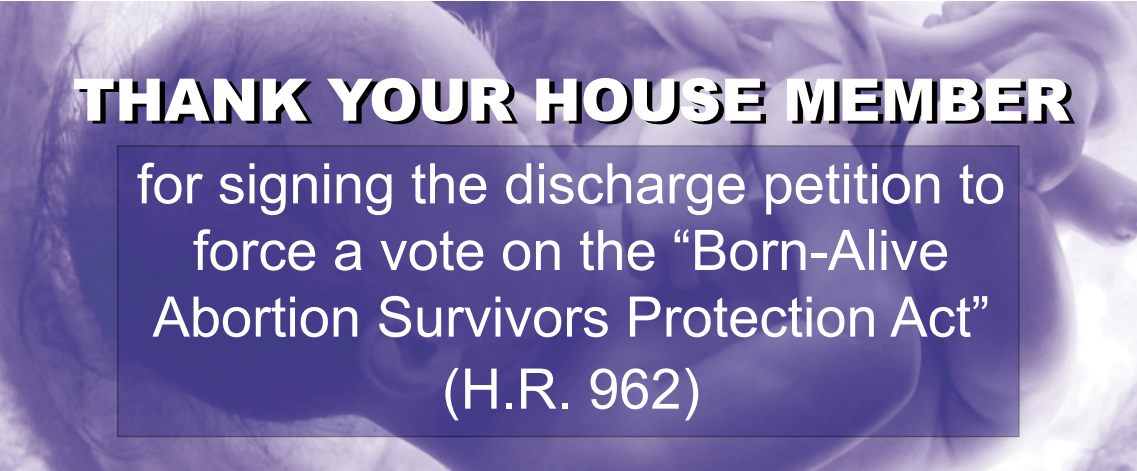

Born-Alive Abortion Survivors Protection Act



The Born-Alive Act (H.R. 962) that has repeatedly been thwarted on the federal level, will be attempted in West Virginia during the next legislative session in Charleston. The session starts January 9, 2020.

We have received word that Nancy Pelosi and the House Democrats have declined, once again, to vote on a bill to protect babies born alive as a result of a failed abortion. The Republicans have tried to get the Born-Alive Abortion Survivors Protection Act to the floor for a vote, but have been blocked at every turn by the majority party. Representatives Kay Granger and Cathy McMorris Rodgers (both Republicans) have gone on the House floor to request a vote to discharge the bill from Committee, but both were gaveled “out of order.”

This made the 75th time and counting that the House Democrats have blocked action on the bill. We have moved so far away from the promise of America’s founding document that makes the right to life the first unalienable right. Instead, we have come to the point where babies are being left abandoned to die, while legislation that would provide medical care is denied.

We can be proud of the West Virginia Congressional delegation for their support for this legislation. When Republican Whip Steve Scalise prepared a discharge petition to bypass the Democratic block of the legislation, all three of our Representatives signed the petition. David McKinley (1st District), Alex Mooney (2nd District) and Carol Miller (3rd District) all deserve thanks for their opposition to infanticide.

Earlier this year, the Senate voted on the bill, but it failed to receive the 2/3’s necessary to overcome the Democratic filibuster. Once again, we can be proud of our Senators from West Virginia, both of whom voted for the bill to ban the practice of infanticide. Contact Senators Shelley Moore Capito and Joe Manchin to thank them for the vote.

Here in West Virginia, we believe we can pass the Born-Alive Abortion Survivors Protection Act in the next legislative session. We know that babies have been left to die in WV following failed abortions. You can see the testimony of a nurse on our web site at wvforlife.org. She found a baby dying on a utility room counter in a West Virginia teaching hospital. Her testimony is powerful.

Improving the WV Living Will in 2020

This coming Legislative Session, West Virginians for Life (WVFL) will again introduce “Options in Living Wills” to amend the WV Code provisions dealing with Living Wills and Combined Medical Power of Attorney and Living Wills.

Together with the Diocese of Wheeling-Charleston and representatives from various groups promoting the rights of disabled persons, WVFL sought to pass this same legislation last year. Although it passed successfully through the Senate, we were unsuccessful in having the Chairman of the Health Committee in the House of Delegates put our bill on the agenda, and so it died.

The bill would amend that portion of the Code that sets forth sample language to be used in Living Wills (and the Combined form). Presently, because of the fact that certain terms are not defined in the Living Will itself but rather elsewhere in the Code, it appears that most people to do not understand that by signing a Living Will, they are agreeing to the removal of artificially-provided food and fluids (by IV or feeding tube), should one doctor find that they are in a terminal condition or in a “persistent vegetative state.” This is dangerous language for several reasons: some PVS patients actually recover consciousness if given enough time to do so; many doctors disagree about the diagnosis of PVS; new therapies are being developed all the time for the treatment of PVS patients; and simply because death by dehydration is an awful and inhumane way to treat a cognitively disabled person who is not otherwise dying.

To prevent this cruel treatment of vulnerable disabled persons as well as the very real possibility of a lack of informed consent, our legislation would amend the form to include an express “check-off” section, where persons would choose whether they want food and fluids artificially provided, or NOT want them, should they be diagnosed as being in a persistent vegetative state.

In the meantime, we advise that the forms being promoted currently around the state NOT be used. Please go to wvforlife.org for a “Will to Live” form tailored to WV state law, with its protective language.

PASS THE BORN-ALIVE ABORTION SURVIVORS PROTECTION ACT IN 2020

Bills that legalize the killing of unborn babies until birth have clearly caused a blurring of the distinction between abortion and infanticide. West Virginians are asking, “Can this happen in West Virginia?”

This bill will protect infants born alive following an attempted abortion. It would require hospitals and medical personnel to exercise the same degree of care for the baby born alive as a result of a failed abortion, as would be given to any other preborn child at the same gestational age. It provides for immediate transport to facilities capable of caring for such children, and it provides for reporting requirements in the event the law isn’t observed.

Pregnant WV Teen Made to Drink Turpentine

In McDowell County in late July, a 15-year old, impregnated by her mother’s boyfriend with her permission to have intercourse with the girl, was made to drink turpentine by an aunt to produce a dead baby. This was after the “morning after” pill did not “kill the pregnancy” as the two women were quoted as saying.

Reportedly the teen’s mother, Sharon Kirk, and the father of the baby Daniel Atwell (25 years), were charged and arrested on July 25. Both hale from Bartley. Charged with attempt to kill or injure a person by poison is the aunt, Sherry Kirk (age 62), from War.

West Virginia State Trooper First Class D.G. Pierson is in charge of the case and according to the *Bluefield Daily Telegraph* he said in a criminal complaint, “During the interview, (the juvenile) disclosed that her aunt, Sherry Kirk, had discovered she was pregnant and had actually obtained turpentine from an unknown male,” (The juvenile) went on to state

One of our greatest failures as a society is deeming a life less valuable due to its stage of development. The Latin word "fetus" translates to "little one," and describes a stage of life just like "infant" or "adult" (Pro-Life Action League). Even though a fetus appears strange to the human eye, each one has immeasurable worth. The fact that this fetus cannot speak for itself does not mean its life should be held to a lower standard. In fact, it makes it more imperative that someone speak on behalf of the fetus. The horrible truth is that as babies are being burned to death during saline abortions, or being ripped limb from



limb with a surgical clamp in a second-trimester abortion, no one is giving them the voices they so desperately deserve.

"For You created my inmost being; You knit me together in my mother's womb" (Psalm 139.13). The gift of life is an astonishing continuum beginning with the formation of a zygote, and miraculously ending with adulthood. Every human, no matter his stage of development, has value and purpose. God unfathomably hand-picked each one of us according to His plan, and it has never been up to us to decide when to cut an innocent life short.

I am pro-life because it helps women, it helps babies, and because it is what my Savior called me to do. No matter the circumstance, or how cloudy the moral boundaries may seem, only the Lord can decide when to take the life of an unborn child. Every woman struggling with whether or not to keep a child must try to place herself in His hands. Perhaps Dr. Seuss articulates it best: "Even though you can't see or hear them at all, a persons a person, no matter how small" (Seuss 47).

No to Abortion

According to worldometers, over 3,000 unborn babies are aborted each day in America. According to the Webster's Dictionary, abortion is "The intentional ending of pregnancy and the expulsion of an unborn baby." Abortions should be avoided because they bring pain and fear to the fetus, take the life of a helpless baby, and can lead to future medical problems for the mother.

First, babies feel pain and face fear during the abortion procedure. Just at thirteen and a half weeks after conception, surgeons have seen babies jerk, flinch, and recoil from sharp objects. Dr. Bernard Nathanson, an abortionist doctor, recorded the first ultrasound of an abortion. It showed the fetus moving as far away as it possibly could from the intruding abortion device. He had performed thousands of abortions but would not do any after this.

Second, abortion takes the life of a helpless baby. At the moment of conception, a baby is formed. Their DNA has been created. If the fetus was not alive the fetus would not grow. Some would argue that a fetus is not a baby, but a fetal heartbeat can be detected as early as five or six weeks into a pregnancy. The Milton S. Hershey Medical Center has said, "Week 5 is the start of the 'embryonic period.' This when all the baby's major systems and structures develop. The embryo's cells multiply and start to take on specific functions."

Third, abortions lead to future



medical problems for the mother. Mothers, after an abortion, may face pelvic infections, blood clots in the uterus, scar tissue on the uterine wall, or possibly a tear on the wall of the uterus. Having an abortion makes it more difficult for the mother to conceive again. If she is able to carry another baby, the baby can face a preterm birth, low birth weight, and even death near the end of the pregnancy.

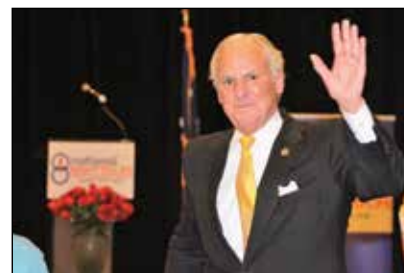

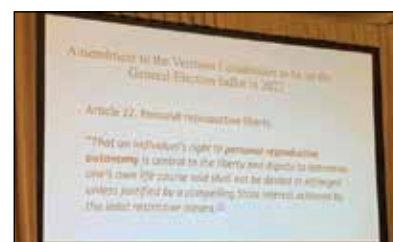

Jaime Bigley is married to an “amazing husband,” Warren, and they have four beautiful daughters ranging in age from 24 to 4. They also have a granddaughter, Olive, who is almost two. All girls in this family! She attended West Virginia University and West Virginia University at Parkersburg and received her BA in Psychology/Sociology. She has also completed coursework toward an MA in Communication, but that hasn’t been finished yet. “Someday,” she laments. Jaime has worked in various capacities in the developmental disabilities field for 25 years and is currently employed as a Service Coordinator (“a fancy word for overworked Case Manager”) in the WV Title XIX Waiver Program.

Jaime feels she has always been pro-life. Her parents are big pro-lifers and raised her and the siblings that way. From the time she was a teenager, she would make and wear pro-life t-shirts to school, make signs, etc. and in college she was a vocal advocate for the unborn in whatever setting the subject of abortion was brought up. There wasn’t a local pro-life group in the town in which she grew up, but her church was always participating in pro-life activities, walks for life, and holding fundraisers for the local Women’s Care Center.

As the result of a personal experience, Jaime’s involvement and renewed dedication to the pro-life movement came about. In 2013, she and her husband found out they were expecting very early on (around 4 weeks). She was almost 8 weeks along when it was discovered that the pregnancy was ectopic. Her tube ruptured, causing severe internal bleeding and an emergency surgery to remove the pregnancy to save her life had to be performed. They were devastated. Jaime researched pictures of what an 8-week old baby - her baby - looked like and knowing that he/she died as a result of the surgery, just because of an attachment in the wrong place, was - and is still - heartbreaking. This renewed her passion for educating women and making sure that they know that their babies are very human from the moment of conception. With everything going on in the country today regarding life and death, she really felt it was time to step up and do whatever possible to save babies!! Currently, she is the WVFL chapter leader for Wood County and is super excited to get out there and fight for life!

“The biggest challenge we face is false knowledge, as well as the lack of knowledge, regarding what abortion is and does,” Jaime says. She believes “women need to be reached and educated regarding what is going on inside their wombs; that they need to be supported and showered with love, compassion, and understanding as we come alongside them.”

Jaime’s biggest hope is that the American people would have a change of heart and that they would once again value life as God intended - from conception to natural death. If that would happen, she believes everything else in the pro-life movement would fall into place. She also truly hopes for the overturning of Roe v Wade - the monster that started us on this downhill slide - and for the closing down of every abortion facility in the country due to lack of business!

WVFL Treasurer’s Article Big Tech Bias — Blocking Pro-Life Groups From Advertising

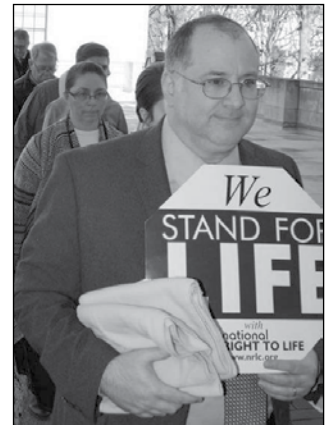
Dear West Virginia Pro-Lifers,

Pro-life groups/ads have been blocked by Facebook, Twitter, Pinterest, Instagram, et al. As reported by IrishCentral and Lifesite: Facebook CEO Mark Zuckerberg admitted that Facebook deliberately banned pro-life ads from the US during the Irish abortion referendum after the Irish government told them they had no laws either way to cover such foreign advertising.

The depth of their bias is being revealed. As reported by Mat Staver (Liberty Counsel): a senior software engineer at Google stepped out of the shadows to confirm that Google is “very politically biased.” Greg Coppola has a Ph.D. in computer science. that Sherry made her drink the turpentine.”

According to McDowell County Magistrate court, Kirk has been released on a \$50,000 surety bond.

Both Atwell and Baker, who were charged with sexual assault related crimes, are also out on bond.

The state police criminal complaint says the pregnant teen was hospitalized and is now in the care of social workers. It is not clear whether the unborn baby survived.

Horrific as this is, similar stories of abuse are not uncommon. One of the reasons women and girls give for obtaining an abortion is due to pressure from the father of the child or other family members.

Jessica Stanton wrote an article “Protecting Women and Girls from Coerced Abortions,” for The American Feminist (Fall/Winter 2016) which reads in part:

“In a study conducted by Dr. Angela Lanfranchi, Dr. Ian Gentles, and Dr. Elizabeth Ring–Cassidy published in 2013 in ‘Complications: Abortion’s Impact on Women’, the authors asked 101 women to share their abortion stories. When they were asked whether they were ‘coerced or pressured into having the abortion,’ 48% of the women answered, ‘Yes,’ and said that the pressure or coercion was in the form of violence or threat. Concerning adolescent abortion, 8% of minors whose parents learned about their pregnancies from a third-party felt forced to abort; 6% of that group stated they were subjected to physical violence.”

In recent years, the pro-life group Live Action has done undercover work in Planned Parenthood facilities and found that members of their group posing as sex traffickers were given advice on how the very girls they victimized could get abortions.
