## PRO-LIFE CANDIDATES SCORE BIG IN WEST VIRGINIA

Though no one knows yet who the next US President will be. West Virginia, not surprisingly, gave all five of its electoral votes to Donald Trump on November 3. With 70% of the vote, Shelley Moore Capito won another US Senate 6-vear term. All three congressional incumbents retained their seats. In the 1st Congressional District. David McKinley defeated his opponent by a margin of 69-31%. Alex Mooney won in the 2nd Congressional District by 70.521 votes and in the 3rd Congressional District, Carol Miller won a second term by 42 percentage points. This completed a pro-life sweep of the entire slate of federal candidates, all of whom were endorsed by West Virginians for Life Political Action Committee (WVL-PAC).

In the six statewide races, the WVL-PAC enjoyed a 100% success rate. Governor Jim Justice won with 65% of the vote. Patrick Morrisey won reelection to the Attorney General office ensuring that pro-life legislation will be defended, if challenged. Mac Warner, for the second time, beat pro-abortion Natalie Tennant for Secretary of State. John McCuskey will continue as State Auditor. Agriculture Commissioner Kent Leonhardt will remain in that role. The biggest surprise of the Board of Public Works races was that of Riley Moore. The first Republican to win the seat of State Treasurer in 92 years, Moore defeated long-time incumbent John Perdue by a margin of 56-44%.

Of the 16 Senate races in which endorsements were made, 14 were winners. Twenty-five of 34 senators support pro-life policies. The net gain of pro-life senators is +2.

WVL-PAC can report an 82% winning percentage in the House of Delegates. Of the 17 WVL-PAC losses, at least two winners are also pro-life. Seventy-eight of the 100 members of the State House will be

# From the President



Actions Speak Louder than Words Dear friends,

As I write this, election day is passed, but the election is not yet over in the race for President of the United States. Ballots are still being tallied and recounts are still under way. The possibility of President Trump being re-elected is slim, but West Virginians have shown their support by voting 70% to 30% for the President. He carried every county in West Virginia.

In addition, West Virginians voted overwhelmingly for state pro-life candidates. All the pro-life Congressional candidates won re-election and we have pro-life leadership in all six statewide races, including the Governor. Pro-life support increased to super-majorities in both the House of Delegates and the Senate. West Virginia has become the most pro-life state in the country.

The AP VoteCast poll taken on election day of 2020, shows that West Virginia has the highest percentage of people replying pro-life to the questions: Do you think abortion should be legal in all or most cases? Do you think abortion should be illegal in all or most cases? West Virginians answered pro-life, that is "illegal," by 64% to 35%. This was the highest pro-life response of any state in the union. Nationally, those with pro-life positions voted 78% to 27% for Trump, but the number of

these pro-lifers wasn't quite enough to overcome the enormous well-funded opposition, who also had the media to help undermine President Trump's support.

National Right Life Committee's post-election national poll showed that 23% of voters cited abortion as the most important issue and voted prolife. An additional 18% of voters cited abortion as the most important issue and voted for candidates favoring abortion. Pro-life candidates had a 5% benefit in this election. These data help to explain the failure of the "blue wave" to materialize. In fact, the down-ballot results show an increase in pro-life winners across the country in Congressional and state seats.

I am so proud to live in a state where the citizens show so much respect for the dignity of every human person and can be counted on to support life from conception to natural death. This position is at the heart of all the love you show for your fellow human beings. Thank you for your help in spreading this culture of life in West Virginia.

# For Women Who will Change Their Minds, Abortion Pill Reversal is a Godsend

West Virginians for Life will be working to amend the Women's Right to Know Law with the **Abortion Pill Reversal Act** in the upcoming legislative session. The abortion pill referred to in this legislation is RU-486, which was developed in France by Roussel-Uclaf back in early 1980's. The pill was not available in the United States until 1994, when the Clinton administration colluded with pro-abortion forces to set up Danco Laboratories, a sub-licensee of the eugenics-founded Population Council to distribute the drug in America.

The pill's chemical name is Mifepristone. It works to kill the unborn baby in the womb by inhibiting Progesterone, the chemical in the mother's pregnant body to cause the lining of the uterus to thicken to nourish the life of the tiny baby. The abortion pill removes this source of nourishment thus causing the baby to die.

The pill is not 100% successful. There is a 15% "failure" rate. That is, the baby survives 15% of the time. In addition, in around 40% of cases, tissue is retained in the uterus and

a follow-up surgical procedure must be done to complete the abortion. To avoid these problems, a second pill called Misoprostol is given, which causes the uterus to contract and remove the contents, that is, the dead baby. Misoprostol is to be taken at home 24 to 48 hours after ingesting the abortion pill in the office. The mother experiences a painful, bloody

delivery at home without the help of medical personnel. She may be traumatized, especially if she sees her dead baby.

Sales for the abortion pill were very slow in the beginning, but they have

picked up recently. In West Virginia, 18.6% of abortions were done using the pill in 2016. By 2019, pill use had jumped to 41.3% of abortions, which is now similar to that found nationwide.

Often, after taking the pill in the office and returning home, the woman has second thoughts about the abortion. Our bill introduces the

possibility of reversing the effects of the abortion pill. It is possible to take additional Progesterone. which restores the body's ability to maintain the lining of the uterus in order to sustain the baby. Our bill requires that the abortionist provide the woman with the information on the abortion pill reversal along with the website where she can get information on how to find a doctor to help her. The success rate for this method is between 55% and 70%. There are no long-term negative effects on the baby from being exposed to the abortion pill.

Dr. George Delgado developed the abortion reversal procedure and thousands of women in the United States and 14 other countries have successfully used his method to give birth to their babies. Nine states currently have laws providing for doctors to give this important reversal information to their clients, including Arizona, Arkansas, South Dakota, Utah, Idaho, North Dakota, Kentucky, Oklahoma and Nebraska. We intend to join them in protecting women and the lives of their unborn babies.

The Abortion Pill Reversal Act will not tell physicians how to practice medicine but will simply require them to inform their clients that abortion reversal is possible. It will protect the rights of women by providing them with information and will not place obstacles on women seeking abortions. Informed consent legislation is not an attack on personal freedom, but a guarantee of it. It is constitutional because it safeguards a woman's right to know.

You can help by contacting your legislators to tell them you support passage of the **Abortion Pill Reversal Act**. In addition, you can encourage others to call and to watch the movie *Unplanned*. WVFL regrets that the March 15 Pro-Life Rally Day is cancelled.

Our second effort at the Legislature will be, again, to try to amend the WV Code where it gives model language for Living Wills, Medical Powers of Attorney, and Combined Forms (both a Living Will and a Medical Power of Attorney).

We have attempted this for the past two years but met up with resistance within some hospital communities.

Organizations that represent the interests of disabled persons are especially anxious to see this happen. Some cognitively disabled persons, in the so-called "vegetative state," are being denied artificially-provided food and fluids, which leads to death by dehydration.

The legal forms in the Code would be clarified so that people can designate whether or not they wish to receive food and fluids in those conditions, and that if opting NOT to receive them, they are informed that it may hasten or cause their death. Also, since there is frequent misdiagnosis of the "persistent vegetative state," we have increased the number of physicians that must certify the condition from only one to two.

### Unborn children could possibly be saved by abortion pill reversal.

The abortion pill, known as Mifiprex or RU-486, is the first drug in a two-drug, multi-step process that has the potential to be reversed after the first step. The abortion pill reversal hotline has received over 2,000 calls from hopeful women who changed their minds once they realized the pill might be reversed.

The first step, using Mifepristone, blocks progesterone effects, shutting down the system that provides nutrients to the baby.

A second drug, Misoprostol, taken a day or so later, triggers severe cramping and bleeding to the mother in order to expel the baby.

It may be possible for a woman to reverse the intended effects of Mifepristone within 24 to 48 hours after taking it, but before taking Misoprostol, with a safe and effective reversal method for women who change their minds. Babies have already been saved this way!

# Congratulations to Justice Amy Coney Barrett

November 3 general election. NRL Senior Policy Advisor Douglas Johnson commented: "Those who refer to this nomination and confirmation as 'illegitimate' speak constitutional nonsense and dangerous nonsense. Under the Constitution, two things are required to seat a Supreme Court justice -- the President's nomination, and the Senate's consent; in 2016 the Senate exercised its constitutional prerogative to withhold consent. 

# Pro-Life Profile

Cathy Weiss is retired with one daughter, Amanda, and two grandchildren, Ryan (7) and Rachel (5). She and her family all live in Huntington, WV.

Cathy attended college for a period of time at Marshall University, and retired from Calgon Carbon after working there for 33 years.

Cathy attends the Catholic parish in Huntington, where she is very involved teaching Sunday School (K-1) and helping with the adult Bible study She belongs to the parish women's guild, the Catholic Daughters of the Americas, the Blue Army, and the parish knitting group. She is also involved with the Pea Ridge Woman's Club, local Republican

women's group, and the Cabell County Chapter of West Virginians for Life. Cathy first became involved with the pro-life movement in 2001, around the age of 55. While she never agreed with abortion, she initially felt it had nothing to do with her and never would have dreamed it was so prevalent. She began watching EWTN a great deal, where they spoke strongly against abortion. At first, she tried to ignore the topic, but soon felt she had to listen and was convinced that she must get involved.

Cathy joined the Cabell County Chapter of WVFL in 2001. She's been the Chapter Vice President for 18 years. As a member, she helps to staff the tables at the Cabell County Fair, Pumpkin Festival, and Barboursville Fall Festival, as well as work various bake sales throughout the year. She has also been the coordinator for the National Life Chain in Huntington for the past 18 years.

Cathy shares that she has remained involved over the years because, once a person knows the truth about abortion and euthanasia, he or she has a responsibility to stay involved. Cathy adds that Chapter Leader George Wallace and wife Yoko have been a great example to her of such dedication.

Cathy feels that the biggest challenge she faces in the right to live movement is getting local pastors involved in the pro-life cause. For the past 18 years, she has hand delivered a letter with attachments telling pastors she would like to meet with them. Sadly, she shares that it has been unbelievable how few pastors seem to care. In general, the few who have met with her say they are personally pro-life but will not bring it up to their congregations.

Furthermore, in 2019, she delivered information to local black churches stressing how the abortion industry, especially Planned Parenthood, targets minorities. Even though she did get to speak to four pastors, none showed any interest in teaching their people about the gravity and far-reaching effects of this problem.

Her own pastor has permitted her to have a table in the parish hall showing the development of the baby in the womb, as well as displaying the small pink and blue flags in the rectory yard in commemoration of the victims of abortion. Thankfully, her pastor does preach and pray for respect for life from conception to natural death.


Cathy's hope is that we can overcome the lies which have been taught in recent years about the so-called "right" to abortion. With so little regard for human life, it only follows that euthanasia will increase in the US, as it has in Europe.

She also understands that lack of chastity is at the root of the problem of abortion. Cathy feels that if our pastors and parents would teach the truth about the evil of abortion, while emphasizing the mercy of God, they could undo much of the confusion and harm in our current culture... harm which can lead to lack of self-esteem, abuse, and serious health problems, such as drug abuse, alcoholism, and suicide.


