

Roe Overturned & HB 302 Passes!

On June 24, 2022, the U.S. Supreme Court released their ruling in *Dobbs v. Jackson*, overturning the 1973 Roe v. Wade decision. "We are thrilled with the decision rendered by the Supreme Court today. We are so happy to be able to live in a country that is no longer damaged by the legalized killing of our most vulnerable members," said Dr. Wanda Franz, president of WVFL.

In the majority opinion, written by Justice Samuel Alito, the High Court noted: "Roe was egregiously wrong from the start. Its reasoning was exceptionally weak, and the decision has had damaging consequences. And far from bringing about a national settlement of the abortion issue, Roe and Casey have enflamed debate and deepened division. It is time to heed the Constitution and return the issue of abortion to the people's elected representatives."

The West Virginia legislature picked up this newly-given mantle of authority when Governor Justice added abortion law to a special session during the summer. The result was HB 302, which passed both WV houses on September 13. This law will protect the majority of babies and their mothers, with exceptions for life of the mother, rape, and incest. Although this is a victory, work remains to be done during the regular session.

The Rhonda Williamson Story

Hi, my name is Rhonda Williamson, and this is my story.

As a little girl I loved playing with dolls, pretending that they were my real babies. I would feed, bathe and change their diapers and clothes. I was in awe, trying to catch a glimpse of my future with my own babies. I always wanted 2 kids - a boy and a girl, but I guess that's what most people want.

Now let's fast forward to the time when I'm ready to start having babies - my early twenties. It took a little while to get pregnant and I didn't think much about it because it doesn't always happen right off. I finally got that first positive pregnancy test and I was over the moon with excitement. But 6 months later, my dream became a nightmare. I went to the ER because I was spotting. They tried to find a

heartbeat but the only heartbeat they could find was mine. I was shattered. Labor was induced and I gave birth to a beautiful baby boy that had no life in him. I was told many times to keep trying and two years later, I got another positive pregnancy test. About 2-1/2 weeks later I began cramping and spotting and was told that I had lost another beautiful baby. I tried for many more years after that and never got pregnant again. I prayed daily for God to let me have a baby.

One day I took a leap of faith and made a sign that says "Please Don't Abort, I will Adopt Your Baby". Every week, for 2-1/2 months. I made the 1-1/2 hour drive to the abortion clinic in Charleston and held that sign as I watched pregnant women go into the clinic to abort their babies.

I was in the convenience store next

to my house and told the lady that worked there that I had been going to the abortion clinic every week with my sign and how much I wanted to adopt a baby. I did not know it at the time, but that lady had a young daughter who was pregnant and did not want to keep her baby. That lady told her daughter about me, but her daughter still went to the abortion clinic to have an abortion. As it happened, I was there that day with my sign. I had no idea who she was. I didn't even know her name. While she was in the abortion clinic, I guess whatever her Mom had told her about me and then seeing me with my sign, played on her heart. She told her mom that the next time I came into the store to get my phone number, because she was going to let me adopt her baby.

A Good Beginning; Work Yet To Be Done

Dear Friends.

We are celebrating the reversal of *Roe v. Wade* and *Casey*. After nearly 50 years, the Constitution of the United States no longer includes a "right to abortion." Justice Alito did a beautiful job of making the case that the Constitution should never have included such a ludicrous proposition. The right to life of each of us has been validated, because, when the right to life of any human person is threatened, we are all threatened.

The reversal of *Roe v. Wade* has not made abortion illegal. It has returned the debate to the state legislatures, as provided by our Constitution. We have reached a point that we are in the "end game." We are able to protect unborn babies in West Virginia and we are eager to do so; however, this will not be easy. We will have to continue to work with the legislature. We may need to compromise on some issues as we reach consensus on the wording of the bill. When we work with our legislators on legislation, West Virginians for Life has always supported language that saves the most possible number of lives.

We have been present in Charleston during the entire Special Session, and we are currently working to make changes in the Senate version of House Bill HB 302. We are very pleased that both versions of the bill would ban most abortions from fertilization. This is an incredible accomplishment. We are truly thankful that our legislators recognize the importance of protecting human life from its beginning. [See page 3.]

One of the most emotional issues is the question of including rape and incest exceptions in the bill. It has been difficult to do a good job of educating about this issue due to the media talking point that the rape victim suffers terribly if she has to carry the pregnancy to term. WVFL believes these exceptions for rape do everything to help the perpetrator hide the crime and do nothing to help the victim. Abortion is not a cure for rape. In recent years, all the bills we have passed have not included these exceptions. [See the article on rape and incest on page 3.]

We are just beginning our work toward a truly pro-life West Virginia. Thank you for your continuing support in our fight for life.

After 50 Years of Fight for Inches, HB 302 Wins Miles

For years, the people of West Virginia have been showing up at the polls to vote for pro-life lawmakers. They have promised to defend the most vulnerable of us all, the unborn babies of West Virginia. Now, unborn babies are protected from the moment of implantation under West Virginia law.

This is one of the greatest pro-life laws to pass in the United States in the post-*Roe* era! The people of West Virginia have fought for inches. This month, we have won miles.

The decision in *Dobbs* finally moved control of abortion away from the courts. The reversal of *Roe v. Wade* returned the debate on abortion to the state legislatures, as provided by our Constitution. This allowed the people of West Virginia to begin protecting women and unborn babies from the devastating reality of abortion.

West Virginians for Life (WVFL) sprang into action to lobby the pro-life lawmakers as soon as they picked up abortion in the post-Dobbs special session. After a stall in July, Senator Takubo and Delegate McGeehan worked together on an agreement that would save the vast majority of babies from abortion. This new draft, however, did include some exceptions: life of the mother, a medically non-viable baby, medical emergency, and rape and incest.

WVFL recognizes the worth of every unborn baby's life, and

Senate President Craig Blair with WVFL fought hard against the exceptions for rape and incest. But for the bill to pass, and the only abortion clinic in West Virginia to stop performing abortions, those exceptions were necessary. The next effort was to focus on tightening the exceptions to keep them from being

In the tragic situation that an adult woman has been raped, a report must be filed with law enforcement before she receives an abortion, which must be performed before eight weeks post-implantation. If a minor has this crime committed against her, she has the option to report directly to law enforcement, or a healthcare worker who is a mandatory reporter will make the report for her. For a minor, the abortion must be performed before 14 weeks post-implantation. These guidelines will help protect victims from being pressured into an abortion by their predator.

In addition, an authorized report must be given to the abortionist, and the abortion can only be provided in a hospital by doctors. No other medical provider may perform an abortion. A doctor who knowingly and willfully performs or commits an illegal abortion will be stripped of his or her medical license. Anyone who is not a doctor, or a doctor who has lost his or her license and performs an abortion, will face up to ten years in jail. All abortions performed in the state of West Virginia are subject to reporting. This will prevent medical providers from committing numerous illegal abortions because, if one specific doctor continually performs abortions, an investigation can be requested.

These tight restrictions were modeled after other states, which have had success with this language. Not only has this strategy proved to protect women and unborn babies from abortion, but it has not been abused.

A Loving Response to Rape and Incest

Rape and incest are likely two of the most horrific things that can happen to a woman. She is a victim of a brutal attack, and the attacker should receive the full power of the law against him. The victim should receive the greatest sympathy and support from our social system. Few would dispute this.

The question is: What constitutes the best support for the victims of these crimes? Answers to this question have been presented by Robin Atkins. She is a certified Mental Health Specialist, who has spent her nearly 20-year career helping the victims of rape and incest. She serves on the Board of AAPLOG (American Association of Pro-Life Obstetrician-Gynecologists).

Those with a pro-abortion agenda, through the use of the media, have made it appear that abortion is the best way to benefit the victims of rape and incest. However, Robin Atkins explains that, "Abortion is not a treatment for trauma, including rape and incest." Abortion is another form of violence that may also create trauma.

Atkins explains that, far from being a horrific burden, pregnancies following rape are chosen by 50% to 80% of rape victims. It must be pointed out that a pregnant woman has a powerful biological and psychological bond with her unborn child. Biologically-speaking, there are no other relationships that produce the same kind of bonding impact.

In addition, children conceived and born out of such relationships are no different than any other child. Ryan Bomberger's biological mother was raped. He was born and adopted by a loving family. He is a powerful testament against being aborted. He has written:

"I am not the 'rapist's child.' I am her child. I am God's child. I'm one of thousands every year, given the opportunity to live, love and redeem what the rapist tried to destroy. Our stories are full of hope, full of love, full of purpose."

Treatment for rape involves care and counseling. Victims of incest are especially vulnerable and in need of this help. Atkins explains that good practice requires that abortion never be used when other non-violent options are available. Even very young girls, who are capable of becoming pregnant, can have healthy outcomes when they are given good medical care. A healthy woman's body is designed to give birth. When society falls back on abortion as a solution, there is the implication that women's bodies are inherently flawed. from the truth.

Candidate Surveys and Voting Records

The following charts are a service to you describing the pro-life records of the candidates running in this year's primary election. The first four columns consist of selected questions from the West Virginians for Life Candidate Survey. The questions for each are presented here. A "yes" answer is pro-life for all four questions. If no response is indicated, a survey was not received. An asterisk (*) indicates written comments were included.

Among others, the following four selected survey questions were asked:

1 = Would you vote for a bill to outlaw abortions done for the sole purpose of killing a child diagnosed with Down syndrome or some other disability?

2 = Would you vote to prevent the use of tax funds for abortion other than to prevent the death of the mother?

3 = Would you vote for a bill to correct the WV Code on Living Wills, so "vegetative state" patients are not dehydrated to death; so persons considering signing a Living Will are told clearly that CPR, breathing machines, dialysis, and feeding tubes will NOT be provided; and requiring that ORAL food and fluids, such as may be taken by spoon or straw, will always be offered if they are desired and can be safely tolerated?

4 = Would you vote to oppose any legislation that would impose rationing

that intentionally denies treatment on the basis of disability or "quality of life" of those denied treatment?

Born-Alive Bill = Born-Alive Abortion Survivors Protection Act to ensure proper medical care is given to an infant abortion survivor + legal recourse (2/18/2020 in House and 2/19/2020 in Senate). Y is a pro-life vote. N is no. A is for absent.

2nd Chances at Life Act (Abortion Pill Reversal) = Those seeking abortions via chemical method would have to be given information about reversing the procedure once it has begun, if measures are taken swiftly. (4/10/21 in House and 4/10/21 in Senate)

Down Syndrome Bill = Unborn Child with Down Syndrome Protection and Education Act will protect unborn babies from being aborted due to a diagnosis of Down syndrome or other disability by requiring doctors to provide educational materials on the support systems available to families raising children with disabilities. (3/2/22 in Senate and 3/12/22 in House)

HB 302 = Bill to clarify West Virginia's abortion laws. (9/13/22 in both Senate and House)

The "% pro-life votes" column is a compilation of votes from 2013-2020 (Senate) and 2014-2022 (House) and not just the three votes shown.








Pro-Life Profile

Alicia was born in a rural setting, and raised in a conservative church. Unborn and premature babies have been special to her from literally her earliest memory: When her mother was pregnant with her younger sister. she wanted to take the baby out of Mommy's tummy and hold it while it was still very tiny. One of the most special blessings of her life is her parents' 53year marriage.





For decades, Alicia's professional area of interest and training was the age of the Earth. She specialized in being able to defend and teach the truth that nothing in science demands that the Earth is more than several thousand years old. Having evidentially established that reality, her secondary focus with an audience was to demonstrate that, for those who accept Biblical authority, nothing in that Text allows the Earth to be more than several thousand years old. She has been privileged to teach both the science and theology of this issue at the College level. She is humbled by the fact that her layman's Biblical Creation Science seminar continues to minister via DVDs and YouTube.

Over the years, Alicia's love for tiny infants never waned. One of the greatest blessings of her life was volunteering in a Level III NICU, where the tiniest babies are rescued. She was there less than a month before she realized that it was a front-line battleground with regard to the issue of abortion, because the Unit was defining viability.

In the late 1990s, Alicia became aware of some crucial abortionrelated statistics that were being ignored by the mainstream media. In the early 2000s, she wrote a novel, entitled The Executioners, which sought to publicize the truth. An author at heart, Alicia's other books include Understanding the Rapture and Other End Time Events, and Unbound and Unharmed: The Scientific and Historic Evidence Beneath COVID. She has also written some shorter works, including a Grand Canyon visitor's guide and two devotional booklets.

An amazing pro-life volunteer privilege came when Justice For All brought their Exhibit to a college campus near Alicia's home. Their phenomenal preevent training gave Alicia a solid framework for engaging and interacting with those who hold a pro-abortion worldview – or any worldview that differs significantly from one's own. In Alicia's opinion, this training, which effectively balances truth and love in a manner than engages the other person, addresses the biggest challenges facing the pro-life movement today.

In 2020, Alicia came to WV with her husband, Jim, for temporary work. Her heart was pricked when she learned of a possible opening at WVFL – but her commitment at the time prevented her from applying. The window of opportunity closed. Months later, the timing was right to seek a new job. Alicia thought God wanted her to remain in WV, but all the employment doors kept locking. And then, almost to the very day that Alicia's previous job ended, the position at WVFL suddenly and unexpectedly opened again.

Alicia counts it a privilege to step into the role of Program Director at WVFL, where she can continue to help and defend the babies for whom God gave her a special love. She is thankful for this platform, where she prays that she can help realize her hope for the future of the pro-life movement: A group which actively engages their culture with a balance of truth and love.

Since our last chance to write here, our prediction came true, as Roe was finally vacated by our nation's highest court. However, some federal legislators are seeking to codify Roe (or worse) permanently: some state legislators are actually entertaining bills that would not only codify abortion without limits throughout all nine months of pregnancy, but even authorize killing babies after they have been born—up to 28 days after!

Lies from abortion proponents abound. Some claim that pro-life laws don't permit dealing with ectopic pregnancies or conditions that threaten the life of the mother. Others claim that women will be prosecuted


